# Town of Johnson Highway/Public Works Department Monthly Progress Report February, 2021

# **Current Projects:**

- Snow and ice control
  - We have used an estimated 3,200 yards of sand so far (pile is about half gone)
- Salt use is below normal thanks to operator knowledge and some minor adjustments to route
- Crew continues to take trainings that Vermont Local Roads offers. Most recently electrocution safety, trench safety, posted roads and weight limits
- We're beginning to find that the 2018 Ram 2500 (foreman vehicle) isn't able to perform the way it's needed during winter months. Repairs out of warranty are starting to add up
- Began shelfing back snow banks on all routes to make room for additional accumulation and increase visibility
- Winter Grading is under way. Stinger bits were installed on the grader and roads are being smoothed out as time allows. Mitigating the ice layer as we go should help ease mud season in a perfect world
