### INVASIVE SPECIES MANAGEMENT PROJECT ON McCUIN ISLAND

Noah Pollack plans to meet with a group of volunteers on Friday, June 17, from 9:30 -1:00 to clear an area on the island for tenting and add steps. We can and should join them. They plan to cut knotweed and pull out bush honeysuckle with a winch. Our concerns are rife: where and how will they stack knotweed, can the volunteers recognize the rare and fragile plants, how will winching out roots affect the rare plant(s) next to them?

Park behind the Nazarene Church and paddle to the island or paddle from the mouth of the Waterman Brook.

### **ADMINISTRATIVE ITEMS**

Officer selection: no one thinks there's a better person for chair than Lois and no one wants to try. No one is crazy enough to want to be secretary except Sue, so Lois and Sue will continue with their jobs. It is important that responsibilities are spread throughout the group for sustainability going forward.

We need a vice chair, who would lead meetings if the chair were to be absent. Lois suggests that the office should also take the leadership of a project; for example, the vice chair could be the point person for the mission request.

Peter will think about taking it on. We'll discuss it again.

### GOMO KIOSK AND BAT HOUSES

Dean has ordered 3 PT 4x4s for the bat houses and kiosk and will order one more along with hardware. He'll measure the bridge at Journey's End and order the materials necessary to repair the railing, using PT lumber.

### PROJECTS AND PROGRAMS

We have \$2,000 in our budget for communication. Might we use it for creation of videos for community education? We could get people to start thinking about the land as a natural environment, rather than something to be used. It'll be a great day in *that* morning!!
