Secretary's Report: It was moved, seconded, and approved to accept the minutes from 10 July 2024 as printed.

Treasurer's Report: Kelly Vandorn reported the budget is in fine shape at year end although the expenses exceeded the proposed budget by \$1,000. The final numbers should be available at the September meeting; however, Kelly estimates a balance of about \$30,000.

Vermont Studio Center Walking Tour: Liz Kaufman, Community Engagement Coordinator at the Vermont Studio Center shared information about a project to prepare write-ups about each of the historic buildings on their campus and place them on podiums to create a walking tour showcasing their property including their pollinator garden. The Trustees were enthusiastic about the proposed project and offered to help by providing information from long-time Johnson residents with knowledge of past owners and uses of the buildings that have been preserved. Liz will coordinate with Dick as the plans evolve.

Lois Frey reported that the Scavenger Hunt coordinated by Kristen MacDowell as part of the Library's summer program on August 8th was enthusiastically received by a few youngsters. Kelly Vandorn reported that Jacob Vandorn is stepping aside from his volunteer video editing of the JHS programs. He has spent innumerable hours completing all the programs recorded to date. He has done a wonderful job for which the Trustees extend their appreciation.

- <u>Standing Committee Reports</u>:

 * Buildings, Grounds, and Facility Development: Kelly Vandorn reported that the Lettieri's have done a clean-up of the second floor including kitchen shelves, windowsills, windows, woodwork, and stairway railing.
- *Collections & Program Development: Linda Jones reported that Susan Richardson will give a talk about Snowflake Bently on October 27th. She plans to check the availability of Jenna's House for the Sunday afternoon talk. Other suggested programs were a talk about the history of Manchester Lumber (Mike will look into the availability of appropriate representatives of the business.) A program featuring paintings and prints of Johnson covered bridges is another proposed idea. The Program Committee will continue their work.
- *Revenue Development: Lois Frey shared the total sales figures for Tuesday Night Live to date (\$3,703.) As always, we appreciate our volunteer bakers as well as our on-site work crew, who make this event such a success.
